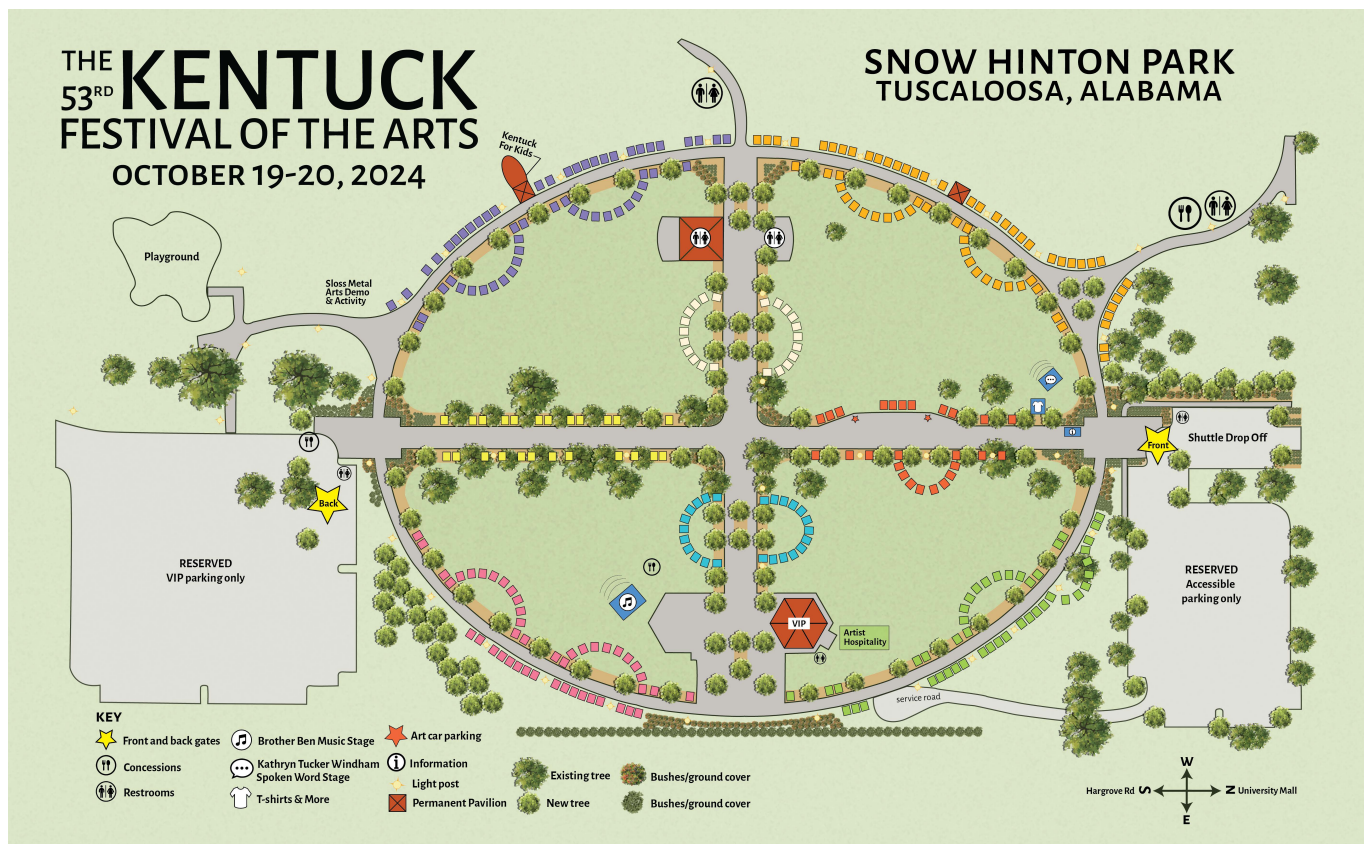

## ABOUT KENTUCK

### The Kentuck Festival of the Arts and the Kentuck Art Center

The Kentuck Festival of the Arts is a juried show in its 53rd year that attracts 10,000-15,000 visitors from across the United States. Along with more than 270 exhibiting artists, the Festival features educational demonstrations, interactive arts areas, children's arts activities, music, storytelling, craft beer, and food trucks. In 2018, the Festival was named 5th in the nation (based on artists' self-reported sales) in the category of Classic and Contemporary Craft Shows by Sunshine Artists Magazine, recognized by Alabama Department of Tourism as one of the top-ten events to attend in Alabama in 2018, and by Alabama Magazine as one of the "Best of Bama 2018." Additionally, the U.S. Library of Congress has named the Festival a "Local Legacy." The Festival was featured on the National Endowment of the Arts website as one of the top arts programs in the state. Kentuck has also been featured in Smithsonian Magazine, Southern Living, American Style Magazine, and National Geographic Traveler.

Festival proceeds help support the funding of next year's Festival and the year-round programming of Kentuck Art Center in historic downtown Northport and throughout Tuscaloosa County. Kentuck Art Center provides year-round programming with the mission to perpetuate the arts, engage the community, and empower the artist. Kentuck's campus is home to 8 artists' studios, 3 gallery spaces, 3 classroom spaces, the Courtyard of Wonders, and Kentuck's Gallery Shop. ## ARTIST SELECTION:

The Kentuck Festival of the Arts is a juried festival nationally recognized for its quality, diversity, and celebration of artistic style ranging from folk to contemporary arts and traditional crafts. Artists who apply are numerically scored by a jury panel of arts professionals on the basis of Kentuck's standards of quality, originality, and creativity. Kentuck's jurors change yearly to maintain the anonymity of the jury process and to ensure a balanced breadth of artwork to keep our patrons coming back every year.

A limited number of artists per category are accepted to provide a diverse and balanced show. A score-based waiting list is maintained in each medium, and cancellations are filled with the highest scoring artists in that medium. Artists will find out their jury status on July 5, 2024 by 5:00pm. Jurors have the option to leave comments on applications, and we can share them upon request. We cannot guarantee that jurors will leave comments on applications.

The Kentuck Staff has no influence on jury scoring or artist selection. Regardless of past attendance in the past, all artists\* must apply and jury into the ~270 available spots at the Kentuck Festival of the Arts.

**Exceptions to the Jury Process and Fee\*:** *Artists who are exempt from the jury process are not eligible to receive awards. However, they may elect to apply, pay the jury fee, & go through the jury process. Jurying in makes them eligible for judging at the Kentuck Festival of the Arts.*

- **Guest Artists** - Notable folk, traditional, and contemporary craft artists who would otherwise not exhibit at a festival without receiving an invitation.
- **Demonstrating Artists** - Artists demonstrating their process at the Festival, in their booth space. If you are interested in participating as a Demonstrating Artist, please indicate this in appropriate application question.
- **Kentuck Artists in the Schools** - Artists who spend Friday morning before the Festival in an area school providing workshops, demonstrations, or presentations to students. In return, artists receive a \$100 stipend for supplies, lunch on Friday, and may check-in early.
- **Back by Special Invitation Awards** - Members of the Kentuck Board of Directors who have purchased a VIP Benefactor ticket have the privilege of inviting an artist of their choice to attend the next Festival without going through the jury process.
- **2023 Award Winning Artists** - \$12,200 total was awarded by judges Glenda Hood (Orlando, FL) and Rebecca Hoffberger (Baltimore, MD). These winners are automatically invited to the 2024 Festival. Again, congratulations!

## **MEDIUM CATEGORIES:**

Artists wishing to enter in more than one medium must submit separate applications, fees, and images in each category. If only one application is accepted, only work in that medium may be exhibited. Artists may enter in no more than two categories. All work must be original and signed handcrafted work. The Kentucky Festival of the Arts reserves the right to re-categorize an artist's application. Artists will be notified of recategorization.

**Clay:** Original clay and porcelain work, functional or sculptural. Machine-made, mass-produced work is not permitted. Use of molds, unless molds are of the artists' creation, are prohibited.

**Fiber:** Includes wearable and non-wearable. No machine-tooled, machine-screen printing, or other forms of mass production are accepted. Machine stitching is permissible.

**Glass:** Functional and sculptural work is accepted. Kiln forming, blowing, molding, or casting, as well as all cold working processes are permitted.

**Jewelry:** **Only those artists accepted in the jewelry category will be able to display jewelry in more than 10% of their booth.** Items made from commercial parts may not be exhibited. If artists are found to be exhibiting items made from commercial parts, they will be asked to leave the Festival.

**Metal:** Sculptural or decorative work made from metal. No jewelry will be accepted in this category.

**Mixed Media:** Work which combines materials from two or more mediums in one piece.

**Natural Materials:** This includes basket weaving, chair caning, brooms, gourds, and other works made from materials found in nature. Leather items should be submitted under the fiber category.

**Photography:** Includes traditional film photography, hand-colored images, emulsion transfers, and digital photography. Only artist's original source material is acceptable.

**Printmaking:** Only hand-pulled original prints are allowed. Prints must be in limited editions, signed, and numbered.

**Sculpture:** Three-dimensional work using additive or subtractive processes in a single medium.

**Two-Dimensional:** Drawing, painting, and digital works. All digital works must be printed on archival quality paper and be signed and numbered as a limited edition of no more than 250. Reproduction prints are not allowed to be submitted for jury.

**Wood:** Original works that are hand tooled, machine-worked, turned or carved.

## **RESTRICTIONS ON WORK THAT YOU MAY DISPLAY:**

Up to 10% of your work may differ from what you sent for jurying. The remainder must be representative of what you sent in for jurying. All works must have the year they were created. Commercially manufactured items, or items made from commercial molds or parts may not be exhibited. All items exhibited and/or offered for sale must be original work, designed and executed by the exhibiting artist(s). Representatives of Kentucky review displays throughout the Festival; we reserve the right to require removal of any work that differs from the images submitted, as well as any inappropriate work or display. Failure to remove such work

or abide by other rules set forth may result in applicant's removal from the Festival and/or applicant being prohibited from future application.

Reproductions of your original work may ONLY be displayed in a portfolio, with clear distinctions between originals and reproductions. Postcards and notecards bearing photo-offset reproductions of your work may be displayed and sold, but not as primary items of display. T-shirts may not be displayed or sold, except with prior approval by the Executive Director. Your booth must be filled with your original work.

If you have any questions about whether a work may be displayed, please check with the Kentuck staff for clarification. In the case of ambiguity, the decision of the Executive Director is final.

### **BOOTH SHARING/COLLABORATIVE WORK:**

Artists working together may apply as one if they collaborate on every piece of work. All co-artists must describe the collaboration. In this case, only one booth fee will be charged. Other artists must pay the full fee even if they choose to share a booth with another artist. Kentuck must approve all non-individual booth set-ups, and approval is not guaranteed.

### **ART VEHICLES:**

Space in the Festival grounds is extremely limited, but we love art cars! Please contact the Kentuck Executive Director at 205-758-1257 by August 1 if you wish to have a vehicle considered for parking in the booths area. All vehicles not authorized to stay by the director are required to be out of the park by 7:00 a.m. Saturday and 8:00 a.m. Sunday for the safety of all. **Artists are not permitted to park behind their booth spaces.**

### **ARTIST AMENITIES:**

- \$12,200 in awards: Best of Show (\$2,000), 2 Awards of Distinction (\$1,500 each), and 12 Merit Awards (\$600 each). Award winners are automatically invited to the 2025 Festival.
- Qualified buyers. Admission per day is \$15, with children 12 and under free with a ticketed adult.
- Booth sitters. Text the number in your artist packet to request a booth sitter.
- Bottled water available at check-in.
- An artists' hospitality tent at the Festival. Fresh doughnuts and hot coffee are available at 7:00 a.m. Saturday and Sunday morning. Drinks and snacks are served throughout the Festival. **Hours for Artist Hospitality are 7 a.m.-4 p.m. on Saturday and 7 a.m.-3 p.m. on Sunday.**
- Drive up unload/load available in most locations. Where drive up unload/load is not available, accommodations may be made for the use of ATVs/golf carts and staff to help transport an artist's set up to their booth space. We will notify you if this option is available at your booth location.
- Onsite security during the Festival is provided by City of Tuscaloosa Police Department from Thursday-Sunday. Additionally, The City of Tuscaloosa is installing a new camera system throughout the park.
- ATM on site. Credit card processing is also available for a 6% processing fee at the Information Building. (Taxes are NOT charged by Kentuck while processing credit cards. Any artist processing a credit card at the Information Building will need to include taxes in the price given to the customer for processing, and the artist is responsible for paying taxes to the City of Tuscaloosa, Tuscaloosa County, and Alabama.)
- VIP program featuring pre-paid Kentuck Bucks that can only be used to purchase art from artists at the Kentuck Festival of the Arts.
- An artists' party with dinner and live music Saturday night at Kentuck Art Center. Judges are introduced, and awards are announced.
- More than \$60,000 spent annually on publicity and advertising (print, radio, TV, social media, and digital) for the Festival.

## **RULES & REGULATIONS:**

### **Festival Hours:**

8:00 a.m. – 5:00 p.m. Saturday, October 19\*

9:00 a.m. to 4:00 p.m. Sunday, October 20

\*Participants in the Festival VIP Program at the Benefactor level have early bird shopping privileges from 8 a.m. until 9 a.m. on Saturday. The park opens to the public at 9 a.m.

- **All artists are required to open their booths and be on site at 8 a.m. Saturday and 9 a.m. Sunday. All artists are required to keep their booths open until 5:00 p.m. on Saturday & until 4:00 p.m. Sunday.**
- **Juried artists must be on-site for the duration of the show. Artist Assistants and booth sitters are only allowed as support staff.** If you open late, allow another artist to share your space, display work which promotes copyright/trademark infringement, is not representative of your application images, close early, or leave early, you will be banned from participation in future Festivals. If extreme weather causes the Festival to close early, staff will inform all artists that they may leave early.
- The Kentuck Festival is a rain or shine outdoor event. Please plan accordingly.
- Kentuck assumes no responsibility for damage or loss while at the Festival. Artists must be prepared to adequately secure their work and personal property.

### **NoNos of the Festival:**

- All tents must be weighted. We recommend 40 pounds of weight per leg.
- To keep the aural environment uncluttered, personal/individual music may not be played on Festival grounds.
- No tobacco use, including smoking, chewing, or vaping.
- No alcohol is permitted, other than the craft beer sold at the Festival.
- No firearms or weapons are allowed in the park.
- No pets of any kind are allowed in the park during the days of the Festival. If you need information on local kennels, please let us know prior to Festival weekend. Service dogs require a separate check-in process.
- **BE NICE OR LEAVE:** No profanity or unkind behavior is allowed. Respect everybody, celebrate and see everybody, and help us live up to our founder Georgine Clarke's intentions that Kentuck is a Heaven of a Place. Kentuck reserves the right to ask artists to leave, and this is left to the discretion of the Executive Director.

## **APPLICATION REQUIREMENTS:**

### **1. Fill out the online application completely.**

By submitting this application, you consent to and authorize the use of any and/or all images of works in promotional literature and other promotional endeavors by the Kentuck Museum Association including but not limited to brochure, print, billboards, television advertisements, and internet display. Kentuck will keep all images of accepted work for publicity and Festival archival files.

- ### **2. Submit three professional-quality digital images of your work, one high-quality image of your booth set up, and a description of your work as specified below.**
- Quality of images can affect acceptance. No artist names, trade names, faces, or likenesses should be visible. Please blur these out, including your signature on works of art.

- For the first three images, fill in the space provided on the application to describe materials, process used, and dimensions. These descriptions will be read during the jury process.
- Images 1-3 must show the range of the work you will be displaying.
- Image 4 must represent how your work will be displayed. Applications submitted without a booth display image will be considered incomplete. Remember...The booth shot is the last thing the juror sees before scoring your work. Many artists stage a booth shot, with emphasis on showing off their work more than an actual booth shot taken at a festival might.

### 3. Pay the non-refundable application fee.

\$35 for "early bird" applications submitted before 11:59 PM CDT/10:59 PM MDT May 15

\$50 for applications submitted from May 16 to June 2

#### Entry Deadline & Acceptance Notification:

Entries must be received by 11:59 PM CDT/10:59 PM MDT on the night of June 2, 2024. Artists will be notified of their jury status by July 5, 2024.

#### Cancellations:

Cancellations must be made in writing and received prior to August 9, 2024 to receive a 100% refund minus \$40 in admin fees. To receive a 50% refund (less \$40 fee), artists must cancel before 5 PM CDT on August 16, 2024. After that date, no refunds will be given for cancellations. **Email to [mbell@kentuck.org](mailto:mbell@kentuck.org) with the subject line ATTN: FESTIVAL CANCELLATION.** No phone calls, please.

We look forward to having many of our long-time artists and many "undiscovered" artists exhibiting in 2024!

## BOOTH INFORMATION:

#### Booth Fees:

##### Single Booths

- \$275 for a standard (not on a paved pathway) booth 10' x 12'
- \$325 for a premium (on a paved pathway) booth 10'x12'
- \$385 for a premium corner booth 10'x12'

##### Double Wide or Double Deep Booths

- \$460 for a standard double deep booth 10' x 24' (\$510 for a premium double deep)
- \$550 for a standard double wide booth 20' x 12' (\$650 for a premium double wide)

IMPORTANT NOTE: You will be informed of your booth space, the type of space, and the booth fee due a couple of days after you receive your acceptance e-mail.

After you receive your booth space, you may pay for your booth by:

- Sending a check payable to Kentuck to: Kentuck Art Center, 503 Main Avenue, Northport, AL 35476. If sending by mail, payments must be postmarked by the deadline date.
- Calling Kentuck at 205-758-1257 during regular business hours with your payment information.
- Paying through Zapplication



**Please do not pay for your booth before receiving your assignment.** If you pay for a booth type that is not the type of booth you were assigned, you may **not** be refunded the difference. When paying online through Zapplication, you will be charged a convenience fee automatically added by the processing agent.

All requests may not be honored but we do our best to place artists in their requested space. Requests for particular booth spaces are processed by time of application, first-come first-served.

Booth fees must be paid by August 2, 2024.

Equipment may be available to rent through Kentuck at a later date, but there are no guarantees that we will have tents, tables, and chairs for rent available in 2024. We recommend all artists plan on providing their own equipment.

#### **Booth Particulars:**

- Limited storage space behind booth.
- Limited number of double & corner booths available; booth assignments and requests are based on time of application.
- Drive-up unloading for most booth spaces, off-site parking in adjacent lot. All vehicles must be off the grounds by 7:00 a.m. Saturday and 8:30 a.m. Sunday, unless you have special permission from the Executive Director.
- Number of Booths: 250+
- Exhibitors must provide their own booth structures, which should be flexible to accommodate trees and irregularities in the park's terrain and must be properly anchored. We recommend 40 pounds of weight per leg. Please make sure your tent or display is secure. Safety first!

#### **BUSINESS LICENSE REQUIRED:**

A combined license from Tuscaloosa County and the State of Alabama (\$35) are required. Information will be sent to participating artists after their acceptance.

#### **SALES TAX:**

10% sales tax on all sales at the Festival are due before you leave the Festival. Tax forms and envelopes for city, county, and state taxes will be in the packet you receive at check-in. The tax folks will be onsite from 3:00-5:00 PM. Sunday, October 20 behind the Artist Hospitality Tent to collect taxes. **They do not give change or accept credit cards so tax payments must be made in exact change or by three separate checks.** Artists who are delinquent in sales taxes will not be allowed to exhibit at the Festival.

#### **ACCOMMODATIONS:**

This is a not home game weekend for the University of Alabama football team. There are numerous hotels/motels in the area. We strongly recommend that you book a room if you are accepted. Hotel recommendations: <https://www.kentuck.org/visitkentuck>.
